This is very disappointing as you will all be aware of how much time and effort DOC and others put into restoring the lakefront grass area for picnics, recreation and enjoying our beautiful scenery. The reinstatement of the grass for was something the local community really valued, and the surface has now been damaged.

A group seen on Thursday skidding on the lawn were in the vicinity young children and other vehicles, creating the potential for serious injury to innocent bystanders.

New way to apply for a fire permit

A new online fire permitting system is being implemented in the Nelson-Tasman district by Fire and Emergency New Zealand on Tuesday 6 August.

"Fire permits are a key part of Fire and Emergency's strategy to reduce the risk of fire, particularly over the summer fire season," Fire and Emergency National Manager Risk Reduction Roxanne Hilliard said. "Fire permitting allows us to engage with New Zealanders to advise them about the types of fire they can or can't light in the prevailing conditions, and to ensure they have the knowledge to manage the fire safely. This reduces the instances of uncontrolled fire emergencies."

Most of Nelson-Tasman is currently in a restricted fire season, so people will need a permit to light many types of fire.

The new system provides the public with a user-friendly web-based system for checking the fire season status in their specific location and applying for all types of fire permits. In addition, applicants will be able to check on the progress of their applications online, view and activate their approved fire permits and apply to renew any expired fire permits or declined fire permit applications.

Roxanne Hilliard said the new National Fire Permit System was an important part of the recently introduced National Framework for Fire Control that contains the policies, processes, tools and systems to support consistent, national and robust fire control across the unified organisation.

"The system is easy to use and effective for both Fire and Emergency and the communities we serve. For the first time we will have easily accessible nationwide information about fire permitting and its effectiveness as a risk reduction tool," Roxanne Hilliard said.

"The new fire permit system is straightforward for all of our permit customers to use, and will provide them with more visibility and ownership of their applications and permits," said Fire and Emergency Principal Rural Fire Officer Ian Reade.

"The new online permit application system is another tool to improve our efficiency in administering open fire management," Ian Reade said. "In light of the devastating fires we experienced in the district earlier this year, providing education on ways to reduce fire risk is vital. The new streamlined process will allow our personnel to focus more on providing fire reduction information to people in the Nelson Tasman district."

Talking about rat control in the Rotoiti Nature Recovery Project September 2019

The Department of Conservation, Nelson Lakes Area Office, plans to control rats over 1128 hectares of the Rotoiti Nature Recovery Project in September 2019 (see map overleaf).

How it is happening

Rat poison bait (Pindone 0.5g/kg) in the form of pellets will be secured in bait stations within the control site.

Timeframe

Bait application will begin on 1st September 2019. The Department of Conservation (DOC) will place warning signs immediately prior to the operation starting.

Why we are controlling rats

Rat predation can take a heavy toll on populations of small native birds. Within the Rotoiti Nature Recovery Project the robin population in particular has declined in the past when rats have not been controlled and increased when rat have been controlled.

Controlling rats during the spring, when birds are breeding, allows bird populations to recover. DOC will monitor the effectiveness of the rat control and the response of native bird populations.

Key facts

Pindone, like any anticoagulant rat poison, is toxic to humans and domestic animals. Poisoning can occur through eating baits or poisoned animals.

Dogs (prohibited in the national park) may get sick from eating a rat or mouse carcass and this risk will remain until carcasses have rotted, perhaps up to six months. These risks can be eliminated by following these simple rules:

- DO NOT touch bait
- WATCH CHILDREN at all times
- DO NOT EAT animals from this area or from within a 2km 'buffer zone' outside the operational area boundary
- Remember, poison baits or carcasses could be DEADLY to DOGS

Observe these rules whenever you see warning signs about pesticides. Warning signs indicate that pesticide residues may still be present in baits or animals. When signs are removed, this means that you can resume normal activities in the area.

Please report suspected vandalism or unauthorised removal of signs. If in doubt, check with DOC, Nelson Lakes Office.

Operational planning

The Department of Conservation assesses and approves all vertebrate pesticide operations on public conservation land on behalf of the Environmental Risk Management Authority (ERMA), following procedures approved by ERMA. DOC approving managers apply conditions to ensure that all legal and policy requirements are met, and that any potential risks of the operation are managed.

The use of this pesticide is a Permitted Activity under Section 36.6.2 of the Tasman Resource Management Plan 2008 (Discharges of Pesticides to Land). DOC is also required to notify the Public Health Officer.

To satisfy ERMA approval to carry out this operation, a detailed assessment of the risks involved in the work was completed. This is called an Assessment of Environmental Effects. A copy for this operation may be viewed at the Nelson Lakes Area Office in St Arnaud. DOC imposes additional conditions on the operation to further safeguard the public and the environment.

We consulted people most affected by this operation prior to finalising the operational detail. This involved considering their concerns and needs regarding the operational method and its timing. We have notified other people using this fact sheet.
